The following rules and regulations apply to ALL contestants:

1. The contestant has never been married, had a marriage annulled or given birth to a child. The contestant is neither a parent nor pregnant. (some situation will be under review by miusa / nu tainment,llc.).

2. The contestant must be a naturally born female and is a citizen, resident or is attending school in the state for which she is competing. Residence or military establishment is acceptable (some exceptions can apply).

3. The contestant will be:

MISS: at least 18 years old and no older than 26 in the year they would participate in the national and the international telecast. (Some exceptions can apply)

4. The contestant is and will continue to be a person of good moral character; she has not committed and will not commit any act inconsistent with the highest standards of public morals and convictions, or that she will reflect unfavorably on NT (Nu Tainment, LLC.) representatives, sponsors and or licensees; she has not appeared and will not appear nude or provocatively in photographs, film or any sort of media made for publicly available films or publications prior to the state, national or international competition.

5. The contestant possessives poise and a good personality.

6. The contestant agrees to conduct herself at all times in such a manner as is consistent with the highest moral and ethical standards. She further agrees to refrain from any act that, at the sole discretion of NT (Nu Tainment, LLC.) is deemed detrimental to the interests of NT (Nu Tainment, LLC.) it's organization; officers, directors, and representatives or sponsors.

7. The contestant hereby releases any claim in which she may have by virtue of her participation in this competition, or any use of her photograph, likeness, voice, or appearance

in the connection with the exercise of any such rights, including advertising and promotional material relating to any such exploitation.

8. The contestant will NOT defame the Pageant, whether it is oral, written or otherwise stated. Defamation of NT (Nu Tainment, LLC.) shall result in automatic relinquishment of my title and prizes.

9. The contestant agrees to permit NT (Nu Tainment, LLC.), sponsors, distributors, networks, stations, licensees, to use her name, picture, likeness, voice, signature, title, art illustration, biographical material, and/or the like of any advertising or publicity relation to the program and/or the Pageant in perpetuity, without any compensation.

10. The contestant hereby represents that the contestant will continue to be a person of good moral character; that she has not committed and will not commit any act inconsistent with the highest standards of public morals and conventions, or that she will reflect unfavorably on the Pageant, its representatives, sponsors, and/or licensees; that she has not appeared in nude or provocative photographs for any film, or publication, prior to, during her reign as the Title holder for NT (Nu Tainment, LLC.) .

11. Contestant will display good sportsmanship and honor the judges' decisions as final. Drinking alcohol and/or smoking is not allowed! You are a role model for many young people. If you are caught drinking or smoking during the competition, you will be immediately disqualified. If you are caught drinking or smoking as a titleholder your title will be immediately revoked and you must return all prizes. If your title is revoked after you compete at the national pageant, you agree to reimburse NT (Nu Tainment, LLC.) for funds spent for your airfare and hotel accommodations for the national pageant (only if flight and hotel accommodations is offered). All contestants are expected to conduct themselves in a ladylike manner while attending the pageant. We will not tolerate anyone making negative remarks about another contestant, the staff, NT (Nu Tainment, LLC.), the judges or the host hotel and venue.

12. NT (Nu Tainment, LLC.) are not responsible for any items that are lost or stolen. Please take/mark all of your belongings. No one besides contestants and staff of the pageant and NT (Nu Tainment, LLC.) will be allowed in the dressing rooms or backstage at any time. This means no hair/make-up artists, family members, or guests. This rule will be strictly enforced. The pageant will provide for a contestant's chaperone to assist with clothing changes.

13. Contestants must attend ALL Scheduled events leading up to the pageant event. The Miss Intercontinental USA organization / NT (Nu Tainment, LLC.) has taken great steps in pre-planning this event. We are dedicated to providing you with a high-quality pageant and production. The scheduled events and rehearsals require advance planning. Attendance information will be made available to the Pageant judges. Contestants are required to arrive on time and participate in all scheduled activities.

14. All contestants agree to abide by all rules set forth by the MIUSA organization / NT (Nu Tainment, LLC.) this and all related documents. If, for any reason, a contestant refuses to and/or fails to fulfill the duties and obligations associated with her title, she will surrender any title and prizes at the sole discretion of NM (Nu Tainment, LLC).

15. All contestants, who are minors, must have a legal guardian present during the pageant weekend. Rehearsals will be open to parents/guardians (subject to approval).

16. No photography or video recording of the pageant show or rehearsals is allowed. This includes cell phones. If anyone is caught taking pictures or recording during the show or rehearsals, they will be asked to leave.

17. All fees paid to NT (Nu Tainment, LLC.) is non-refundable.

18. Titleholders will be required to make appearances throughout their reign. NT (Nu Tainment, LLC.) reserves the right to revoke a title if the titleholder continuously misses appearances.

19. During their reign, titleholders are not allowed to compete in other pageants unless approved by NT (Nu Tainment, LLC.) and are under exclusive contract with NT (Nu Tainment, LLC.) and the MIUSA (Miss Intercontinental USA) organization.

20. All legal matters regarding rules and regulations of this document will be settled in the state of Maryland (United States) and delegate must be present to resolve any legal matter or official representative on their behalf.

NT (Nu Tainment, LLC.) reserves the right to alter or amend this provision, but is under no obligation to do so.

21. All eligibility issues are at the sole discretion of NT (Nu Tainment, LLC.)
